MINISTER'S MESSAGE

Whew! The world may not have completely recovered from the impact of COVID-19's mandatory shutdowns, but based on the notes in my 2023 calendar, the Western Manitoulin Pastoral Charge has made a pretty good attempt!

This was the year that the Meldrum Bay congregation resumed hosting its Easter Sunrise service and community breakfast, played "movie theatre" for six summertime films, held two Sunday evening services (one following a Strawberry Social and the other a Community Potluck Supper), churned out hundreds of Hygiene Kits and dozens of Comfort Quilts as part of the ongoing *Kits and Quilts* project, saw repairs made to its bell tower in anticipation of future roof re-shingling, and extended its "open for worship" season by some weeks. This was also the year that Meldrum Bay experienced trauma and loss, with the death of several key community members.

This was the year that the Silver Water congregation welcomed into the universal family of God four candidates for baptism (one by immersion in Lake Huron!), hosted Community Potluck Suppers for Valentine's Day, St Patrick's Day, and Remembrance Day in support of the Angel Bus, and supported the UCW's many in-house and community projects. This was also the year that Silver Water experienced trauma and loss, with the death of several key community members.

This was the year that the Elizabeth Bay congregation provided a pit stop for the Gore Bay Rotary Club's "Bay to Bay" ride, and welcomed a couple of dozen attendees of the Ainslie Family Reunion to Sunday worship. This was also the year that Elizabeth Bay experienced trauma and loss, with the death of key community members.

If you noticed a common thread through the 2023 experiences of our three congregations, you'd be right. This past year saw more families in the west end grieving the death of loved ones than in any previous year of my ministry here. And that grief has taken a toll on all of us.

In addition these things, for me this was the year of continued collaboration with Rev Mercedes Hughes of Lyons Memorial in creating and facilitating the hybrid WMPC/Lyons Memorial Zoom services. This was the year of penning and distributing weekly *Friday Check-In*s, leading an online Lenten Study, participating in the Canadian Shield Regional Council Licensed Lay Worship Leader Support and Resource Team, and co-supervising and supporting Diaconal Ministry student Kim Inglis of Trinity Manitoulin, Mindemoya. This was the year of participation in the Island Ecumenical Clergy Group's fellowship and community projects, and leadership in the Island Funeral Home's Candlelight Memorial Service. This was the year of seemingly endless false starts and roadblocks in trying to secure General Commercial Liability Insurance for our two Bay churches – a frustrating process that has only recently been rectified.

As the following pages of this Report make clear, this was the year that many of you continued to fill important roles within your respective congregations or the Charge in general... or you stepped up to take on new roles. This was the year that – remarkably! – our finances remained reasonably stable, despite an almost across-the-board increase in expenses.

And finally... from where I sit, this was the year that the Western Manitoulin Pastoral Charge continued to recover more post-pandemic focus, and re-committed itself to serving God and God's people within our own communities and beyond. That has made this past year – 2023 – a pretty wonderful one.

CANADIAN SHIELD REGIONAL COUNCIL (CSRC) REPORT

The Canadian Shield Regional Council held its inaugural in-person *Festival of Faith* in North Bay, in June. Unfortunately Western Manitoulin Pastoral Charge did not have a representative at that learning event.

CSRC's 2023 Annual Meeting was held via Zoom, in November. In addition to the usual accountability reports presented by committees and staff, a proposed budget for 2024 – anticipating a balanced budget of \$664,000 – was passed. It was at this meeting that new CSRC Chair, Rev Nancy Ferguson of Sault Ste Marie, was installed. As well, CSRC voted in favour of the United Church of Canada's Remit 1: Establishing an Autonomous Indigenous Organization.

The United Church of Canada governance structure provides for representation – both ministry personnel and lay members – from each Community of Faith/congregation on the local Regional

Council. At this time, only the Silver Water congregation has a CSRC rep. If you are a member of the Meldrum Bay or Elizabeth Bay congregations, please consider representing your community in the wider church. Elections for CSRC reps typically take place at the congregational Annual Meetings.

ST ANDREW'S UNITED, MELDRUM BAY, TRUSTEES' REPORT

St. Andrew's United Church in Meldrum Bay is thankful for the ongoing support and generosity of the Dawson Citizens Improvement Association for covering Hydro One costs as well as providing lawn care. We are also so thankful to Lafarge Canada's Meldrum Bay quarry for covering the heating costs at the Church. St. Andrew's is so thankful for these community contributions to the congregation!

In 2023, ongoing evaluation of the needs for building maintenance and upkeep took place. The furnace had its annual check-up and had no issues. The roof is showing signs of age and quotes for its replacement were obtained for further consideration in 2024. In the meantime, however, the bell tower area of the roof was identified as a source of imminent concern as there were signs of incoming water. Emergency repairs to this portion of the roof were completed in the Fall, with the old chimney also being removed, to ensure the roof on the south-west side is not permitting any more water from coming in and causing damage.

A main cause of concern throughout 2023 was the issue of insurance. In the 2022 report, it was noted that the previous insurance coverage was going to be cancelled. That was the case and insurance was cancelled in early 2023. An ongoing search for alternative coverage took place throughout the year without much success for many months. However, toward the end of the year, after approaching a new broker, a carrier was found that would take on a liability policy for the church. Coverage is now in place, effective January 1, 2024. We are so thankful that this finally came together, as a lack of insurance threatened the survival of Meldrum Bay's small congregation. This strengthens our optimism for 2024 and beyond as we continue to assess and address the needs of the building and the maintenance and repairs required to maintain its integrity.

On behalf of the Trustees of St. Andrew's Meldrum Bay, we extend thanks to all those that commit to the upkeep of this lovely, old building. It is indeed a gem in the community of Meldrum Bay.

St Andrew's United Church Meldrum Bay OutReach 2023

Our Congregation chose to share our resources this year, with causes both locally and internationally. Donations were given in support of the Angel Bus, Lyons Memorial Food Bank, WMPC Card Ministry and the Manitoulin Medical Centre.

Our gifts of humanitarian aid were distributed by Mennonite Central Committee to the Ukraine, Zambia and Guatemala. This year we gifted: 37 handmade quilts; 1200 hygiene kits (hand towel, soap, comb, toothbrush, nail clippers and a drawstring bag); and 300+ pieces infant care clothing (night gowns, knit hats, and blankets).

A dedicated team of volunteers gather twice a month at the MB Community Hall from Apr – Nov to fabricate and fill kit bags and work at quilting frames securing the backing, batting and tops with cotton ties to form a quilts. This work carries on throughout the year in volunteers' homes. I can say with confidence that kit bag fabrication and infant clothing production is well underway for the upcoming season!

We gratefully acknowledge the many hours of time and talent offered by our volunteers. Again this year, the bar soap, hand towels and much of the fabric for the quilts were generously donated as gifts in kind. Cash donation received from the UCW and community supporters is used for bulk purchase of supplies. For all of this, thank you.

In a world where the needs seem overwhelming, we have found a way to do something. It is a joy to serve as the hands and feet of Christ.

We can always pray for them, but sometimes for their mental health (and ours) it is appropriate to send cards to let them know that others care for them and love them too. For many years now our church has sent cards - this year we sent 1382 cards total for weekly, Easter cards 309, and Christmas cards 325 for a total of 2016 church cards in 2023. Many of our church family are old or live alone or have health issues or have no one to help celebrate the highlights of their lives and sometime a card in the mail can help. Sympathy cards are sent too, so it is so helpful if you let me know of someone who would like a card or let our Minister Rev. Janice Frame or our Minister Emeritus Erwin Thompson - Retired- know and if we have a good address we will do our best to send a card.

Sometimes we think of those we have lost and would like to remember them. You can always donate to the Church In Memoriam and the name will get into our Memoriam Book that is kept in the church for all to see at any time.

We try to reach out in other ways too. We have a food basket at the back of the church for donations. Many collect Farquhar milk bags - they go to CC McLean Public School- for every 1000 bags all counted and folded the school receives \$50.00. Janice volunteered to serve as Acting Secretary, and offered an Opening Prayer.

Moved by Molly, seconded by Joyce, that voting privileges be extended to adherents. Carried. Moved by Marty, seconded by Erwin, that the Draft Agenda as corrected be the agenda for the meeting. Carried.

Moved by Kris, seconded by Marty, that the Minutes of the 2021 Elizabeth Bay United Annual Meeting, as printed in the Western Manitoulin Pastoral Charge 2022 Annual Report, be accepted. Carried.

Business Arising from the Minutes

Organ in Storage Room

As the organ in the storage room has not yet been disposed of, Nicole, Bruce, and Colin will do so. The "spare" organ – donated by Jean and Arthur Addison – in the sanctuary will then be moved into the storage room.

Building Maintenance

As Clayton Foster has not yet replaced the roof shingles on the outdoor privy, it was agreed that Nicole and Bruce would approach Clayton for the pieces of steel roofing he had offered, and make the necessary repairs. It was agreed that the privy itself is in good condition and does not need to be replaced.

2022 Reports

Congregational Standing Committee Reports

Moved by Joyce, seconded by Molly, that the Trustees Report and the Treasurer's Narrative Report be received for information. Carried.

Treasurer's 2022 Financial Statement

Moved by Marty, seconded by Kris, that the Treasurer's Elizabeth Bay United 2022 Financial Statement be received for information. Carried.

New Business

Building Maintenance

It was agreed that Nicole and Bruce apply spray foam to the crack in the stone foundation at the back of the church.

Contribution to WMPC Central Fund

Moved by Joyce, seconded by Molly, that Elizabeth Bay United's 2023 contribution to the WMPC Central Fund remain at \$600/month (\$7,200/year), with the possibility of making an additional contribution at the end of the year. Carried.

Additional Financial Notes

It was agreed that the long-standing tradition of donating \$70/year to the *Sleeping Children Around the World* organization be continued. As well, it was agreed that \$300/year be donated to the United Church of Canada's Mission and Service Fund in addition to the M&S contributions received through offering envelopes.

Insurance Update

On behalf of the Trustees, Janice explained that notice was received last fall that effective Jan 6, 2023, INTACT Insurance would no longer provide insurance coverage of any kind for Elizabeth Bay United, as the church is open only seasonally. Contact with the Canadian Shield Regional Council for advice was unhelpful. Contact with the United Church of Canada national office resulted in the completion of a new policy application, which was then ignored when forwarded to the agent recommended by the UCC.

A search for a carrier through a local broker has been ongoing. VanHorn Insurance has approached seven insurance companies regarding coverage. Three refused outright, four others have yet to reply despite numerous prompts. As a result, the congregation is currently operating without insurance.

It was thought that posting a "Enter at Your Own Risk" sign would not be helpful. Although the UCC owns the Elizabeth Bay United facility and property, it offers it to the congregation in trust, with the expectation that there is adequate insurance coverage. Without insurance, could the UCC demand that the congregation no longer use the facility? Janice did know the answer to this question.

Erwin wondered if a petition regarding insurance coverage for seasonal facilities could be presented to General Council.

Janice will again approach Rev Melody Duncanson-Hales, the Canadian Regional Council Support Person for property matters, for advice.
